Notice was issued to the parties for first hearing in the Commission on **6.12.2022**.

2. Both parties are present. As per the respondent PIO, the information was already provided to the appellant, but despite that he has filed this Second Appeal, contending that the information is deficient. The respondent PIO had asked the appellant (vide Letter No. 419 Dated 28.10.2022) to list the deficiencies, if any. The appellant was then invited to the office of respondent PIO and supplied another copy of the information, on 4.11.2022. The appellant confirmed that he has received the information.
