**ORDER:**

1. The RTI application is dated 14.01.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 17.02.2022 and second appeal was filed in the Commission on 29.08.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

3. In today's hearing the appellant states that no information has been supplied to him and further mentions about his letter dated 28.11.2022, which has been sent by the appellant relating to the respondent PIO via email.

5. In view of above, the respondent PIO is directed to supply the information to the appellant as per RTI application within 10 days through registered post along with a copy to the Commission. In case, information could not traced / supplied then PIO is directed to file an affidavit in context to AC: 3947 of 2022. The original affidavit be sent to the appellant by hand or through registered post and a copy of the same be sent to the undersigned Bench through email, by the next date of hearing.
6. The appellant is advised to point out deficiencies, if any, on receipt of the information within 7 days, failing it is will be presumed that information supplied is sufficient and nothing is to say deficient in the supplied information
