ORDER

1. This order may be read with reference to the Order dated 26.10.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Smt. Kamaljit Kaur, appellant comes present in person before the Bench to attend the hearing. She states that she has not been provided complete information by the PIO so far.
3. Shri Iqbal Singh, previous PIO-cum-Panchayat Secretary, Gram Panchayat, Mullanpur Khurd, District Fatehgarh Sahib comes present to attend the hearing in person before the Bench. He states that he has brought along the information for handing over the same and hands over copy of the same duly attested to the appellant in the court itself.
4. On perusal of the same, the appellant states that she has not been supplied original bills for the material purchases for the development works carried out by the Gram Panchayat. On the asking of the Bench, the respondent states that the information as available in the official records has been supplied to the appellant and attested copies of the bills have been provided.

5. Shri Iqbal Singh, PIO-cum-Panchayat Secretary, Gram Panchayat, Mullanpur Khurd, is directed to pay compensation of Rs.4,000/- to the appellant by cheque or draft and also to file reply to the Show Cause Notice. He is also directed to file an affidavit on e-stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.3952 of 2022 has been supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

6. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
