ORDER:

1. The RTI application is dated 20.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 31.10.2022 the second appeal was filed in the Commission on 05.01.2023 Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and the hearing has been fixed for today.

2. In today's hearing, the appellant, Sh. Manjinder Singh states that no information has been supplied to him.

3. The respondent PIO is absent without any intimation to the Commission.

4. Commission takes a serious view of the casual approach of the Respondent / PIO, as Respondent PIO is absent in spite of registered post notice issued to him by the Commission, which shows PIO's casual attitude towards the directions of the Commission. The absence of the PIO is viewed seriously and it has also affected hearing and disposal of the case. In pursuance of this, the PIO is directed to file a written submission in response to the Notice of the Commission and should present this case personally (through cisco webex), on the next date of hearing, failing which penal consequences shall follow.

5. In view of the foregoing, <u>respondent PIO, O/o RTA, Faridkot is directed to show cause</u> in writing or through affidavit under Section 20(1) of the RTI Act, as to why penalty be not imposed upon him for willful delay/ denial of the information to the RTI applicant and why the compensation be not awarded to the complainant under Section 19 (8)(b) of the Act for detriment suffered.
