ORDER:

1. This case may be read with the reference to the previous order dated 18.05.2023.

2. In today's hearing, appellant states that information is still pending from the respondent PIO.

- 3. Respondent PIO is absent consecutively second time without any intimation to the Commission.
- After examining the case file, it is observed that appellant filed RTI application on 20.09.2022 and for non-furnishing the information he filed First Appeal to the First Appellate Authority on 31.10.2022 and second appeal in the Commission on 05.01.2023.
- 5. Notice of hearing was issued to the parties on 02.02.2023 by the undersigned Bench and was dispatched on 06.02.2023 for hearing on 18.05.2023. It is observed that ample time was there from 06.02.2023 to 18.05.2023 but respondent PIO did not bother to represent this case or for supplying the requisite information. Accordingly, show cause notice was issued to the respondent PIO on 18.05.2023 as he was absent without intimation even after issuing the registered post notice to him by the Commission. Commission takes a serious view of the casual approach of the Respondent PIO as it leads to wastage of precious time and resources of the Commission.
- A call is made to the Secretary, RTA, faridkot, Ms. Veerpal Kaur (M: 9988713653),
 PCS during the hearing and she intimates the Commission that she recently joined
 the Faridkot office and further requests for an adjournment to go through the matter
 to resolve the issue accordingly.
- 7. Respondent PIO is directed to appear along with relevant record on the next date of hearing at Commission positively so that case could be concluded.
