## ORDER:

 The RTI application is dated 23.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 02.11.2022 the second appeal was filed in the Commission on 05.01.2023 Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and the hearing has been fixed for today.

Hearing through CISCO Webex

- 2. In today's hearing, the respondent states that information had already been supplied to the appellant in another appeal case number 4578 / 2022 which was disposed off by the undersigned Bench on 01.03.2023.
- 3. Appellant is absent in spite of registered post notice issued to him by the Commission.
- 4. After going through the case file, it is observed that the notice of hearing, which was issued to the appellant as per the address in the case file, received back by the Commission vide diary no. 4446 dated 15.02.2023 with the remarks 'redirected to ITI Girls Ferozepur and ITI (W) ਵਿਚ ਇਸ ਨਾਮ ਦਾ ਪ੍ਰਾਪਤ ਕਰਤਾ ਨਹੀਂ ਹੈ ਫਾਜ਼ਿਲਕਾ ਤਕਸੀਮ ਹੋਵੇ ਜਾਂ ਵਾਪਿਸ ਜਾਵੇ dated 13.02.2023, which is taken on record.

Perusal of both the files (AC: 397 of 2023 and AC: 4578 of 2022) shows that information was supplied to the appellant in AC: 4578 of 2022 on 30.01.2023 against the demanded information as per RTI application attached in that appeal case. It is observed that no information is demanded in the RTI application attached in this instant appeal case. Nothing is clear and specific in the RTI application of the present appeal case. No communication is received from the appellant after filing case in the Commission, which is sheer wastage of precious time and resources of the Commission. There is no use to prolong such kind of cases.

5. In wake of above, no further cause of action is required in this case. Therefore, this instant appeal case is **disposed of & closed**. Copy of the order be sent to the parties
