**ORDER**

1. This order may be read with reference to the order dated 20.10.2022 passed by this Bench on the previous hearing.
2. Shri Amarjit Singh comes present in person before the Bench on behalf of Shri Gurmej Lal, appellant and states that the information has not been received by the appellant.
3. Shri Raj Kumar, Clerk, Municipal Council, Sultanpur Lodhi, comes present to attend the hearing in person before the Bench on behalf of the PIO/Respondent. He states that the information has been sent to the appellant by registered post. He also hands over a copy to the representative of appellant and also produces a copy of the same before the Bench.
4. The Bench directs the representative of appellant and respondent to sit together in the adjoining court room and the respondent shall explain to the representative of the appellant the details of information supplied and then to report back to the Bench.
5. Post meeting, after going through the information, the representative of appellant still expresses dis-satisfaction and states it to be partial information. On the asking of the Bench, the respondent states that the information as available in the official records has been supplied to the appellant.
6. Post deliberations, the Bench directs the PIO to file an affidavit on e-stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.3996/2022 has been supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. The original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.
7. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
