**ORDER**

1. The RTI application is dated 02.12.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 19.04.2022 and the second appeal was filed in the Commission on 31.08.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The case has been heard today in the Commission's office at Chandigarh. Shri Saroop Singh, appellant states that no information has been supplied to him yet. A letter dated 23.09.2022 from the Appellant has been received by the bench, which is taken on record.

3. Shri Saroop Singh, SDO states that the Appellant is asking about the status of the complaint which was done is relating to Shri Amandeep Singh, SDO and the same could not be provided as per the instructions given by Govt. Of Punjab vide letter dated 09.08.2021.

4. Post deliberations, the Bench disagrees with the PIO and directs the PIO to supply the point wise information (i.e. enquiry report or its current status) to Shri Saroop Singh, appellant by the next date of hearing through registered post.

5. The PIO concerned is directed to appear in person along with information supplied and related documents, on the next date of hearing at the Commission.

6. With the aforesaid directions, the matter is adjourned. **Both the concerned parties are directed to come up for hearing on 23.11.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
