Order

The RTI Application is dated 6.4.2022 vide which the appellant has sought information as enumerated in his RTI Application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 5.7.2022 and Second Appeal was filed in the Commission on 14.8.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today i.e. 4.10.2022.

The appellant further states that SSS Board Punjab has recommended list of candidates for appointment of Science Mistress against the Recruitment Notice 1/2006 who belong to SC category against the posts of reserved quota of Ex- Servicemen General Female Ward. He requests the Commission to direct the respondent to supply him copy of memos under which category of these candidates have been changed as S.C. The appellant has sent the list of candidates of Ex-serviceman Category issued by SSS Board, Punjab which is taken on record.
