1. The RTI application is dated **25.5.2022** vide which the appellant has sought information:-

4) Illegal Colonies ਨੂੰ Demolish ਕਰਨ ਦਾ Record + ਭੇਜੇ ਗਏ Notice+ other ਕਾਰਵਾਈ ਦਾ Record ਹਰ Colony Wise ਦੇਣਾ।

5) ਹਰ Illegal Colony ਦੀ Papra Act ਮੁਤਾਬਕ Assesment Sheet ਦੇਣੀ। Approved+ Illegal Colony ਦੀ ਤਾਂ ਜੋ Govt Exchequer + ਨਗਰ ਕੋਸਲ ਦੇ Huge Loss ਦੀ ਭਰਪਾਈ ਕਰਾਈ ਜਾ ਸਕੇ।

6) ਜਿਸ Colony ਵਿੱਚੋਂ Papra Act ਮੁਤਾਬਕ Revenue Nagar Council ਨੂੰ ਨਹੀਂ ਆਇਆ ਕਾਰਵਾਈ Action Taken ਦੀ Report ਹਰ Colony ਦੀ ਦੇਣੀ।

First Appeal was filed with the First Appellate Authority (FAA) on **27.6.2022** and Second Appeal was filed in the Commission on **31.8.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **20.1.2023**.
