ORDER

1. This order may be read with reference to the order dated 20.10.2022 passed by this Bench during the previous hearing.
2. The case has been heard today. Shri Saroop Singh, appellant comes present to attend the hearing in person before the Bench.
3. Shri Dheeraj Pal, Sr. XEN, Operation Division, PSPCL, Amloh also comes present to attend the hearing in person before the Bench and states that the information has been supplied to the appellant vide letter dated 22.11.2022 by registered post. The appellant denies its receipt. He also states that enquiry into the complaint mentioned in the RTI application has been got conducted and completed and its copy has also been supplied to the appellant.
4. Since the appellant expresses his dis-satisfaction over the information supplied, the Bench directs the respondent and the PIO to sit in the adjoining court room and explain to the appellant the details of information supplied and then to report back.
5. Post meeting, the appellant still is not satisfied. As such, the Bench directs the PIO to call the appellant to his office and allow him access to the relevant record and supply him the documents as are identified by the appellant after inspection of record, before the next hearing.

6. The appellant states that he has been put to a lot of harassment by the respondent in his effort to obtain information and observes that action be taken against the PIO.

7. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 14.12.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
