ORDER

- 1. This order may be read with the reference to the previous order dated 03.11.2022 passed by this Bench on the previous hearing.
- 2. The case has been heard today. Shri Tejinder Singh, appellant comes present to attend the hearing through cisco webex.
- 3. Shri Dilbagh Singh, Sub Fire Officer, M.C. Amritsar comes present to attend the hearing through cisco webex and states that information on point No.2 has been sent to the appellant vide letter dated 27.10.2022 by speed post and sent to Hon'ble Commission by e.mail on 31.01.2022.
- 4. The appellant expresses satisfaction over the information supplied on point no.2, however, states that information on point No.1 which is to be supplied by Shri Nirmaljeet Verma (BI) who has not come present today, is still pending.
- 5. The Bench observes that the PIO O/o Municipal Town Planner, M.C. Amritsar has not come present nor has supplied information to the appellant nor he has allowed the appellant inspection of record. The amount of penalty imposed on the PIO has also not been deposited. The Bench takes serious note of the non-compliance of directions of the Bench.
- 6.. The PIO O/o Municipal Town Planner, Municipal Corporation, Amritsar is again directed to deposit the proof of having deposited the amount of penalty in the Govt. Treasury before the Bench as also comply with the directions of the Bench in its entirety. He is also directed to appear in person before the Bench, failing which the Bench will be constrained to issued BAILABLE WARRANT to ensure his presence before the Bench..

7. With the aforesaid directions, the matter is adjourned. To come up for hearing on 31.01.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh. Copies of the order be sent to the concerned parties.
