**ORDER** 

The RTI application is dated 8.2.2022 vide which the appellant has sought information as enumerated in his RTI application. The appellant contended that he is not satisfied with the reply filed by the respondent as the representation dated 6.10.2021 has already been received in the office of the Chief Minster, Punjab and he has submitted receipt given by the receipt clerk to the postal authorities, which he has taken from the Postal Department. He has also placed on record, a copy of a representation/complaint dated 6.10.2021 sent to the Chief Minister, Punjab. Since, the respondent has specifically replied that the representation dated 6.10.2021 has not been received in the office, no further directions can be given to the respondent. Since, the appellant has placed on record a copy of the representation dated 6.10.2021, a copy of the same along with the annexures is being sent to Sh. Manvesh Singh Sidhu, IAS, Secretary Labour to look into the matter and take appropriate action as per law.
- 6. Accordingly, the case is disposed of and closed.
