#### ORDER:

1. This order may be read with reference to the previous order dated 14.12.2022 vide which respondent, Ms. Kulwinder Kaur stated that reply had already been supplied to the appellant in appeal case no. 386 of 2021, which was disposed of & closed by the undersigned Bench on 29.09.2021. She added that reply was again sent to the appellant via email dated 12.12.2022.

One more opportunity was awarded to the appellant to represent this case on the next date of hearing to clear the facts of this case, failing which case will be decided in his absence. Matter was adjourned for further hearing on 14.02.2023 i.e. today.

- 2. In today's hearing, both the parties are present.
- 3. Respondent, Ms. Kulwinder Kaur states that both the cases (AC: 4095 of 2022 and AC: 386 of 2021) are same with the same IPO number.
- 4. Appellant states that both the cases are different with the different IPO numbers. He adds that reply in connection with the present case is still pending.
- 5. After hearing both the parties and examining the case files (AC: 4095 of 2022 and AC: 386 of 2021) it is observed that both RTI applications filed with different IPOs and respondent PIO is directed to supply the reply/information to the appellant as per RTI application in the present case through registered post within seven days after receipt of this order.
- Appellant is advised to go through the information, once he had received and point out discrepancy within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard.
- 7. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
- 8. To come up on **19.04.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application). Copy of the order be sent to the parties.
