

# Appeal Case No. 41 of 2022 (Video Conference Proceedings)

- 2. Both parties are present. The appellant is represented by Sh. Manpreet Singh. The respondent PIO, represented by Sh. Amandeep Singh, SA from the office of SSP, Patiala, has made a submission vide Letter No. 2427 Dated 1.11.2022, whereby he has appended a copy of the same number on which the information pertaining to point no. 2 has been supplied on three CDs. The appellant has signed a receipt to this effect. With regard to point no. 8, the respondent states that the available information has already been given vide Letter No. 2186 Dated 22.9.2022, which was received in the Commission and supplied to the appellant. The appellant, however, continues to insist that the complete record sought at point no. 8 has not been supplied.
- 3. The respondent PIO is hereby directed to provide a written reply to point no. 8 of the RTI application stating clearly that the information/document pertaining to applications by Raj Singh and Jagtar Singh to the concerned court, are not available in the record. This must be done within 15 days of the receipt of this Order.
