ORDER

The RTI application is dated 15.6.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 15.7.2022 and second appeal was filed in the Commission on 2.9.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information as per his RTI application:-

- (2):- ਸ਼੍ਰੀ ਮਾਨ ਜੀ ਮਿਤੀ-8/6/2022 ਤੋਂ ਲੈ ਕੇ ਮਿਤੀ-10/6/2022 ਤੱਕ ਅਪਵਾਇਸਟ ਨੂੰ ਰਿਜ਼ਡਿਊਲ ਕੀਤਾ ਗਿਆ, ਉਹਨਾਂ ਦੀ ਤਸਦੀਕਸ਼ੁਦਾ ਲਿਸਟ ਦਿੱਤੀ ਜਾਵੇ ।
- (3):- ਸ਼੍ਰੀ ਮਾਨ ਜੀ ਮਿਤੀ-8/6/2022 ਤੋਂ ਲੈ ਕੇ ਮਿਤੀ-10/6/2022 ਨੂੰ ਕੁਲ ਕਿੰਨੇ ਡਾਕੂਮੈਂਟ ਰਜਿਸਟਰ ਕੀਤੇ ਗਏ, ਉਹਨਾਂ ਡਾਕੂਮੈਂਟਾਂ ਦੇ ਨੰਬਰ ਦੀ ਤਸਦੀਕਸ਼ੁਦਾ ਲਿਸਟ ਦਿੱਤੀ ਜਾਵੇ ।
- (4):- ਸ਼੍ਰੀ ਮਾਨ ਜੀ ਮਿਤੀ-8/6/2022 ਤੋਂ ਲੈ ਕੇ ਮਿਤੀ-10/6/2022 ਤੱਕ ਰਜਿਸਟਰ ਹੋਏ ਡਾਕੂਮੈਂਟ ਦੀ ਫੋਟੋ ਦੀ ਮਿਤੀ ਅਤੇ ਟਾਇਮ ਦਸਿਆ ਜਾਵੇ, ਉਹਨਾਂ ਫੋਟੋਆ ਦੇ ਪ੍ਰਿੰਟ ਦੀ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ ।
- (5):- ਸ਼੍ਰੀ ਮਾਨ ਜੀ ਮਿਤੀ-8/6/2022 ਤੋਂ ਲੈ ਕੇ ਮਿਤੀ-10/6/2022 ਤੱਕ ਡਾਕੂਮੈਂਟ ਰਜਿਸਟਰ ਕਰਨ ਸਮੇਂ ਰਜਿਸਟਰੀ ਕਲੱਰਕ ਅਤੇ ਅਧਿਕਾਰੀ ਦਾ ਨਾਮ ਦਸਿਆ ਜਾਵੇ ।

are taken on record. However, the respondent-Public Information Officer submits that the information sought will be supplied to the appellant within two weeks. He further requested to close the case.

4. After deliberations with the respondent, the directions are issued to the respondent-Public Information Officer to supply the information except the information covered under Section 8 which is exempted and in accordance with Section 10 of the RTI Act, 2005 which is reproduced below:-

“10. (1) Where a request for access to information is rejected on the ground that it is in relation to information which is exempt from disclosure, then, notwithstanding anything contained in this Act, access may be provided to that part of the record which does not contain any information which is exempt from disclosure under this Act and which can reasonably be severed from any part that contains exempt information.”

5. With these directions, the case is disposed of and closed. However, the appellant is at liberty to approach the Commission within four weeks in case he does not receive the same.
