## **Appeal Case No. 4114 of 2022**

2. Both parties are absent. The respondent PIO has submitted a copy of reply sent to the appellant vide Letter No. 1153/EE/C Dated 8.6.2022. In a said reply the appellant was informed that the information sought by him was not only “voluminous” but would also need to be collected and compiled. The PIO has cited a number of decisions by the Hon’ble Supreme Court of India, Central Information Commission and Punjab State Information Commission in support of his decision to withhold the requested information. The respondent had also invited the appellant to inspect any specific record in his office at 10.00 am on 13.6.2022. The appellant has not responded to the offer.

3. In view of the above, this Appeal is accordingly **Disposed of**.
