#### ORDER:

- 1. The RTI application is dated 13.10.2022 vide which the appellant has sought information regarding Complaint Dated 22.4.2021, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on 28.6.2022 and Second Appeal was filed in the Commission on 5.9.2022 under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on 19.1.2023.
- 2. The PIO-cum-Deputy District Manager, Sh. Gagandeep Singh accompanied by Navneet Kaur, SA, appeared before this Bench on 23.1.23 and resubmitted the replies sent to the appellant with proper indexing of the information provided.
- 3. The Commission finds that the information requested at point No. 1, by way of the report etc. of an enquiry conducted by the Vigilance Branch of the Punjab Mandi Board on the appellant's complaint, has been denied citing Central Information Commission's Order Dated 8.2.2017 (CIC/SV/A215/000649). The Commission has examined said Order wherein a report of the Central Vigilance Office (CVO) was denied under Section 8(1)(g) of the RTI Act, 2005.
- 4. The Commission is of the view that the matter under investigation by the Vigilance Branch of Punjab Mandi Board does not attract the provisions of Section 8(1)(g) and must be therefore provided to the appellant. The respondent PIO, Punjab Mandi Board, Mohali is directed to provide a copy the enquiry report etc. sought at point no. 1 of the RTI application, to the appellant with a copy to this Commission, forthwith.
