ORDER:

- This order may be read with reference to the previous order dated 12.4.2023 vide which penalty amounting Rs. 5,000/- was imposed on the respondent PIO, Sh. Vipin Kumar (EO). Matter was adjourned to 7.6.2023.
- 2. In today's hearing both the parties are present.
- 3. The appellant states that he has not received the information till date in spite of directions time and again.
- 4. Respondent PIO, Sh. Vipin Kumar (EO) is absent in spite of registered post order sent to him by the Commission passed in the instant appeal case on 12.04.2023, which shows his irresponsible behaviour towards his duties as public servant, which is not acceptable.
- 5. No communication for exemption or information is received from the respondent PIO after the previous hearing held on 12.04.2023, as he did not paid any heed towards the orders of the Commission. He did not bother to appear once even after issuing show cause or imposing penalty. As per the case file, neither challan is received by the Commission nor did intimation regarding information supply, which means PIO is failed to perform his duties.
- 6. In view of forgoing, penalty amounting Rs. 5,000/-which was imposed on the concerned respondent PIO, Sh. Vipin Kumar vide order dated 12.04.2023 is enhanced from Rs. 5,000/-to Rs. 10,000/
- 7. The Drawing and Disbursing Officer of the office of ADC (UD), Ground Floor, District Court Complex, Mansa is directed to <u>deduct the amount of penalty of Rs. 10000/- from the salary of the respondent PIO, Sh. Vipin Kumar (EO)</u> and be deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission:-

- 10. With the aforesaid directions, the matter is adjourned for further hearing on **05.07.2023** at **11:00** A.M. at Punjab State Information Commission. Copy of the order be sent to the parties through registered post.
