**ORDER:**

1. The RTI application is dated 23.05.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereafter FAA) on 08.07.2022 and second appeal was filed in the Commission on 06.09.2022 under Section 19 of the Right to Information Act, 2005 (hereafter RTI Act).
2. Notice of hearing was issued to the parties for hearing on 14.12.2022 through CISCO WEBEX i.e. today.
3. Respondent, Sh. Tarsem Singh states that information is ready with the department and will be supplied to the appellant within one week.
4. After hearing both the parties and examining the case file, respondent PIO is directed to supply the requisite information as per RTI application to the appellant within ten days from today. Appellant is advised to go through the information, once he had received and point out ambiguity within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard. A copy of this order be sent to the PIO, Sh. Vipin Kumar (EO) for his ready reference.
5. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
