ORDER:

1. The RTI application is dated **25.5.2022** vide which the appellant has sought information **regarding Property No. 707-709/B**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **1.8.2022** and Second Appeal was filed in the Commission on **6.9.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **6.12.2022**.

2. Both parties are present. The appellant is present via Video Conference at Bathinda. The respondent PIO, represented by Sh. Navdeep Sharma, Inspector, has submitted a reply to this Commission's Notice of Hearing vide Letter No. 942 Dated 25.11.2022, stating that the information pertains to a third party. Said third party was asked to provide consent for disclosure of the information to the appellant vide Letter No. 494 Dated 20.6.2022. As per the respondent, the stated third party Smt. Rampyari and her grandson Sh. Ramanpreet Singh, have refused to grant consent in writing. The appellant was informed regarding this, vide Letter No. 637 Dated 8.7.2022.

3. The Commission notes that the First Appellate Authority, Joint Commissioner, MC, Patiala, vide his Order No. 271/FAA had directed the respondent PIO to provide the requested information within seven days. As per the appellant, the respondent PIO did not comply with the directions of the FAA.
