**ORDER:**

1. The RTI application is dated 01.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 10.10.2023 and the second appeal was filed in the Commission on 05.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and the hearing has been fixed for today.
2. In today's hearing, the appellant, Sh. Pritam Singh states that incomplete information has been supplied to him. He adds that partial information was denied by stating therein that demanded information is in the question form.
3. The respondent states that partial information has already been supplied to the appellant and partial information was demanded in question form, which are exempted as per RTI Act, 2005.
4. After going through the case file and discussing with the present parties, I am of the view that the RTI application of the appellant is clear and is not in question form. The PIO concerned is directed to go through the RTI application again and supply the pending information as per RTI application to the appellant by registered post under intimation to the Commission within ten days after receipt of this order.
5. Appellant is advised to go through the information, once he had received and point out discrepancy within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard and the case will be decided on merit basis.
6. This case is adjourned and both the parties are directed to come up **on 13.07.2023 at 11:00 A.M. through CISCO-Webex**. Copy of the order be sent to the parties.
