Order

The RTI Application is dated 14.5.2022 vide which the appellant has sought information as enumerated in his RTI Application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 18.6.2022 and Second Appeal was filed in the Commission on 7.9.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today i.e. 20.10.2022.

2. The appellant states that she has sought 7 points information on behalf of her parents. She further states that she has deposited the Rs 1200/- as necessary fee for the information pertaining to point no. 2,3 and 4. She states that she will submits documents pertaining to point no. 5 as asked by the Tehsildar Amritsar-2. She requests the Commission to direct the respondent PIO to provide the information.

3. The representative of the PIO states information related to point no. 1 and 7 is to be supplied by the Registry Clerk. She further states that Information pertaining to point no. 2,3,and 4 is to be provided by the concerned patwari. She further states that information pertaining to point no. 6 is to be provided by the PIO o/o Deputy Commissioner, Amritsar. The representative of the PIO has sent response dated 17.10.2022 which is taken on record.

4. That after hearing both the parties and going through the RTI application, the PIO o/o Tehsildar Amritsar-2 is hereby, directed to provide the information pertaining to the point no.
