ORDER:

1. The RTI application is dated **21.3.2022** vide which the appellant has sought information:

I have submitted a complaint dated 10/06/2021 vide dairy No. 136 addressed to the Managing Direct, Punseed for taking appropriate action against the corrupt practices of Sh. Paramjit Singh, R.M., Ladhawal but no such action to my knowledge has taken place against him till date. Kindly supply me following information, so as to enable me to take appropriate legal action against all guilty including the co-conspirator of Sh. Paramjit Singh, R.M., Ladhawal:-

1. Attested particulars of Name and designation of the officer/official of Punseed to whom my above referred complaint has been marked for further enquiry.
2. Attested copies of status of day to day enquiry proceedings conducted by said officer/official of Punseed on my aforesaid complaint.
3. Attested copy of final conclusion report, if any, submitted by said officer/official of Punseed till date on my aforesaid complaint.
4. Attested particulars of name and designation of higher authority who is authorized and competent to take departmental action against the concerned officer/official of Punseed who has failed to take any action on my aforesaid complaint till date.
5. Attested copy of departmental instructions/ rules prescribing procedure for taking action on such like complaints.

Notice was issued to the parties for first hearing in the Commission on **14.12.2022**.

2. Both parties are present. The respondent PIO-cum-JA, Sh. Rajesh Kumar, has submitted a copy of a reply sent to the appellant vide Letter No. 3836-37 Dated 2.12.2022, wherein the appellant was informed that the complaint cited in the RTI application is still under process as conveyed by the General Manager, HR.

3. In view of the above, there is no further cause for action and this Appeal is accordingly **Disposed of**.
