**ORDER:**

1. This case may be read with the reference to the previous order dated 01.02.2023.
2. Ms. Ranjit Kaur, appellant states that incomplete information has been supplied to her and that her representative, Shri K.S. Lakhanpal, Advocate has filed a rejoinder vide letter dated 22.02.2023 to the department as well as to the Bench, which is seen and taken on record.
3. Shri R.K. Arora, Advocate representative of the department submits point wise attested copy of the reply dated 17.02.2023 to the appellant as well as to the Bench, during the hearing, which is seen and taken on record. He also mentions that the information as available in their official record has been provided to the appellant and apart from that nothing is available in their official record.
4. Post deliberations, the Bench directs the PIO to file an affidavit on non-judicial stamp paper, within 21 days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in official records has been supplied to the appellant vide letter dated 17.02.2023 (along with annexures) in AC: 4168 / 2022. It is further stated that nothing has been concealed therein and the information supplied to the Appellant is true and correct. The original affidavit be sent to the Appellant and the copy of the same be sent to the Bench for record. In view of submissions made by the respondent the show cause notice issued during the previous hearing is **dropped**.
5. With the aforesaid directions. **This case is disposed off and closed**. Copies of the order be sent to the concerned parties.
