He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

4. Respondent PIO is also directed to coordinate with the appellant and call him for inspection of the official record as per RTI application. He is also directed to supply the identified pages as per RTI application to the appellant on his visit, so that case could be concluded on the next date of hearing positively.
