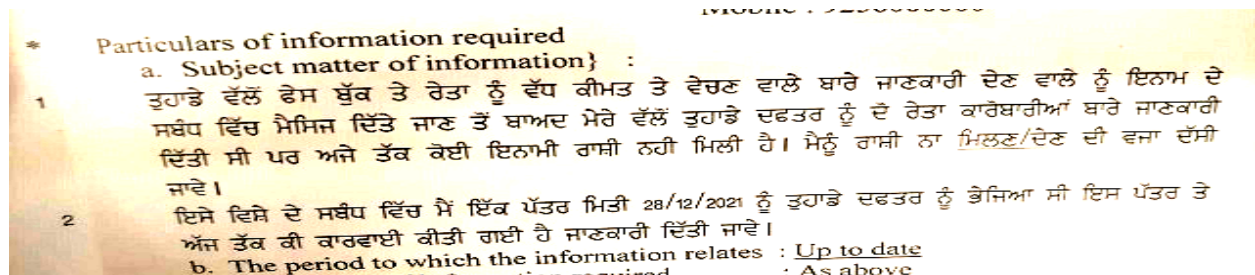

ORDER:

1. The RTI application is dated **9.2.2022** vide which the appellant has sought information:



as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **6.5.2022** and Second Appeal was filed in the Commission on **8.9.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **25.11.2022**.

2. The appellant is absent without intimation. The respondent PIO, has submitted a copy of reply to the Commission's Notice of Hearing vide Letter No. 16365 Dated 18.11.2022, stating that a reply has already been sent to the appellant vide Letter No. 5249 Dated 13.5.2022, wherein he was informed that there is no information available with respect to point no. 1 and that point no. 2 is still under process. Subsequently, a report was received from the mining office, Jalandhar vide Letter No. 322-23 Dated 1.6.2022, stating that no FIR was registered with respect to the information provided by the appellant and cited in this RTI.
