ORDER:

- 1. The RTI application is dated **5.3.2022** vide which the appellant has sought information regarding uprooting and planting the khajoor plants under FT-23 scheme, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **25.4.2022** and Second Appeal was filed in the Commission on **8.9.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **9.12.2022**.
- 2. Both parties are present. The Respondent PIO-cum-EO, Rajesh Kumar, Sh. Narinder Singh, Block Officer, and Sh. Satnam Singh, Clerk, have submitted a reply vide Letter No. 6048 Dated 30.11.2022, which however, doesn't address the two queries in the RTI application. The Respondent PIO's reply is hereby rejected and he is directed to submit a fresh reply to the RTI application addressing both the points along with the requested information as available in his records. This must be done before 16.12.2022.
- 3. The Commission further notes that this RTI application was submitted on 5.3.2022 and the Respondent PIO made no attempt to address the requested information till 30.11.2022. In view of this, the Commission deems it fit to issue the PIO-cum-DFO, this show cause notice.
- 4. The respondent <u>PIO-cum-Divisional Forest Officer, Nawanshahr at Garhshankar,</u> is herewith ordered to **SHOW CAUSE** as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on **5.3.2022**.
