**ORDER:**

1. The RTI application is dated 02.03.2022 vide which the appellant has sought information as enumerated in her RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 11.04.2022 and the second appeal was filed in the Commission on 08.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The case has been heard today in the Commission's office at Chandigarh. Shri Ashok Kumar, AEE states that the information has been sent to Ms. Darshan Kumari, appellant yesterday i.e. 26.10.2022 vide registered post. He also hands over a copy of information to the appellant during the hearing.
3. On the asking of the Bench, appellant seeks some time to go through the supplied information. A written submission has been made by the appellant to the bench of dated 27.10.2022, which is taken on record.
4. Both the parties are sent to the adjacent court room to go through and discuss the information supplied. Both the parties are called again in the Court room before the bench after the discussion.
5. Ms. Darshna Kumari, appellant states that the information in relation to point number 02 has been supplied to her, information in relation to point number 1 is incomplete as one electricity bill is pending i.e. from 04.02.2020 to 10.03.2020 and in relation to point number 3 she is not satisfied with the rules mentioned in manual, which has been supplied to her.
6. Post deliberations, the Bench goes through the supplied information (i.e. copy of information taken during the hearing and handed back to the appellant) and observes that the information in relation to point number 02 and 03 is supplied and information which is pending in relation to point number 01 (one electricity bill is pending i.e. from 04.02.2020 to 10.03.2020). The PIO concerned is directed to supply the information i.e. electricity bill, which is pending to the Appellant within 10 days from today.
7. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
