**ORDER**

1. The RTI application dated 19.03.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 22.04.2022 and second appeal was filed in the Commission on 09.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 13.12.2022 i.e. today.
3. In today's hearing appellant states that no information has been supplied to him. He further states that he got a call from the concerned office regarding visiting the concerned office tomorrow i.e. 14.12.2022 and inspects the official record in connection with RTI application.
4. None is present from the department in spite of registered post notice issued to him by the Commission.
5. After hearing the appellant and examining the case file, appellant is directed to visit the respondent's office tomorrow as respondent called him and respondent PIO is directed to make sure that appellant inspected the official record as per RTI application and supply the identified pages as per RTI application under intimation to the Commission. He is also directed to appear in person on the next date of hearing positively.
6. If the appellant could not visit the concerned office for inspection on the decided date and time then it would be presumed that the appellant has nothing to say and the case will be decided on merits.
