### ORDER

The RTI application is dated 27.4.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 13.5.2022 and second appeal was filed in the Commission on 9.9.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant is absent without intimation. However the representative of the respondent submits that the reply /information sought has already been supplied to the appellant. He has also sent a copy of the same through email which is taken on record. After the perusal of the same it has ascertained that the sought information has already been supplied to the appellant, therefore no further directions can be given to the respondent in this regard. The Commission also observes that the information sought i.e. fee of forms regarding various services are available in the Seva Kendra. The fee being charged for the forms available at Sewa Kendra can be published on the official website in the public interest in compliance of Section 4 (i)(b) of the RTI Act, 2005. Therefore a copy of the same is **being sent** to the company namely M/s to look into the matter and take appropriate action as per law to publish the fee of different forms available at Sewa Kendra. With these directions the case is disposed of and closed.
