**ORDER**

1. The RTI application dated 9.9.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 13.10.2022 and second appeal was filed in the Commission on 6.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for hearing for 24.5.2023 at 11.00 a.m. through CISCO WEBEX application.
3. In today's hearing both the parties are present.
4. The appellant states that sufficient time has elapsed but the sought for information is still awaited.
5. The respondent states that union has refused to give their information, so the information cannot be provided.
6. After hearing both the parties, respondent PIO is directed to supply the requisite information as per RTI application to the appellant within seven days from today.
7. Appellant is advised to go through the information, once he had received and point out discrepancy within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard.
8. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
9. With the aforesaid directions, the matter is adjourned. Both the parties are directed to come up on **24.08.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application).
