Information Officer to supply the complete information. However, the respondent-Public Information Officer submits that the original file pertaining to the RTI application of the appellant is with him and the appellant may inspect the record and if any document will be identified by him, a copy of the same will be supplied.

3. After deliberations with both the parties, it has ascertained that the documents related to letter No. 29107 dated 27.6.2019 issued by the Director, Local Government are not available in the case file shown by the respondent, action taken of which has been sought by the appellant. It is also a fact on record that the said letter was issued by the Director, Local Government to Regional Dy. Director, Local Government, Jalandhar. The regional Dy. Director further sent the said letter to the Executive Officer, Municipal Council, Dasuya vide letter No. 25939 dated 29.7.2019.

4. Accordingly, the respondent-Public Information Officer is directed to bring the original file pertaining to the letter dated 27.6.2019 issued by the Director, Local Government, Punjab for the inspection of the appellant. He is further directed that in case the file/letter is not available on record or no action has been taken on the said letter then an affidavit duly sworn be filed in this regard before the next date of hearing. A copy of the letter dated 29107 dated 27.6.2019 along with the representations of the appellant dated 22.12.2018 and 28.5.2019 handed over the respondent-Public Information Officer during the hearing.
