**ORDER:**

1. The RTI application is dated 09.05.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 29.06.2022 and second appeal was filed in the Commission on 13.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 15.12.2022 at 11.00 a.m. i.e. today.
2. In today's hearing both the parties are present.
3. The appellant states that information is still pending since sufficient time has elapsed.
4. The respondent, Dr. Jasdeep Kaur, Dy. Director, Academics states that making of information is under process and shall be provided soon.
5. After hearing both the parties, the court directs the respondent to provide the sought for information as per RTI application within 7 days.
6. The appellant is also advised to point out the deficiencies on its receipt within 7 days under intimation to the Commission.
7. Both the parties are advised to represent this case on the next date of hearing positively, failing which case will be decided on merit basis.
