**ORDER:**

1. This order may be read with reference to the order dated 02.11.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Arvind Gupta, appellant has not come present in person before the Bench or through cisco webex. However, an e.mail has been received from Shri Madan Lal, father of appellant that he is unable to attend the hearing due to ill health.
3. ASI Narinderpal Singh O/o Police Station, Gidderbaha, District Sri Muktsar Sahib comes present to attend the hearing in person before the Bench on behalf of the PIO. He produces before the Bench a copy of the letter addressed to the Commission wherein it has been stated that enquiry into complaint of appellant No.885-PC 7/2021 was marked to SI Rachhpal Singh No.229/SMS and complaint No.1206-PC 7/2021 was marked to SI Harnek Singh No.735/SMS. Both the complaints were enquired into by the then SHO PS Gidderbaha Inspector Harjit Singh. It has been stated that no other record regarding these complaints is available.
4. On the asking of the Bench, the respondent produces before the Bench copy of enquiry report conducted into both the complaints.

7. With the aforesaid directions, **the instant appeal case is disposed off and closed.**
