ORDER:

1. This order may be read with reference to the order dated 02.11.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Sandeep Kumar Maluja, appellant comes present to attend the hearing in person before the Bench and states that he has not been provided any information.
3. Shri Robin Kataria, Clerk, O/o Tehsildar (Elections), Fazilka comes present to attend the hearing in person before the Bench and states that the information asked for by the appellant is voluminous and it needs to be culled out and compiled from the records and that reply has been given to the appellant vide letter dated 07.07.2022 and produces a copy of the said letter before the Bench.
4. On the asking of the Bench, he explains the information on each point of RTI application. The Bench agrees with the contention of the PIO regarding the information being voluminous on certain points. The Bench also observes that the information as sought by the appellant can also not be denied.
5. Post deliberations, the PIO is directed to call the appellant to his office and allow him access to the relevant official records. The appellant, after inspection of records, will identify the information as per his RTI application and the PIO will supply him the information as is identified by the appellant, before the next hearing.
