ORDER:

1. The RTI application is dated 27.04.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) 07.06.2022 and second appeal was filed in the Commission on 14.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 15.12.2022 at 11.00 a.m. i.e. today.
2. In today's hearing both the parties are present.
3. The appellant states that information with regard to policy papers of medical reimbursement facilities being provided; provided which is incomplete, to the employees of the Board since 2015 is still pending since sufficient time has elapsed.
4. The respondent, Dr. Jasdeep Kaur, Dy. Director, Academics states that no deficiencies letter has been received by the department till date.
5. After hearing both the parties, the court advises the appellant to point out point-wise deficiencies within seven days from today to the respondent so that the same may be removed.
6. The respondent is directed to remove the deficiencies if any on receipt of the deficiencies letter from the appellant within 7 days under intimation to the Commission.
7. Both the parties are advised to represent this case on the next date of hearing positively, failing which case will be decided on merit basis.
8. The matter is adjourned for further hearing on **21.03.2023 at 11:00 A.M. through CISCO WEBEX application**. Copy of the order be sent to the parties.
