3. The PIO states that he has conducted primary inquiry of the appellant and submitted the report to the D.E.O.(SE), Amritsar. The PIO further states that the inquiry has not come to finality and is under process. However he has provided the information to the appellant pertaining to the point no. 1,2,4,9,10 and 11 and the remaining information relates to D.E.O(SE) Amritsar as the complete record along with the statement recorded during the inquiry has been submitted to the office of D.E.O(SE), Amritsar by him. The PIO has sent letter dated 03.01.2022 through email which is taken on record.

3. After hearing the parties and going through the case file, it is ascertained that the PIO has supplied sufficient information to the appellant. Since primary inquiry has been submitted to D.E.O.(SE), Amritsar by the PIO and it has not attained the finality, therefore, remaining information can not be provided to the appellant at this stage. A copy of letter so received from the PIO is **being sent** to the appellant along with the order. No more cause of action is required in this case. Hence this case is disposed of and closed.
