The RTI Application is dated 30.05.2022 vide which the appellant has sought the information as enumerated in his RTI Application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 08.07.2022 and Second Appeal was filed in the Commission on 15.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for 11.11.2022 but adjourned due to administrative reasons and fixed for **hearing today**. The PIO has informed the Commission that RTI application has been transferred to Personnel Department.

2. The appellant has sent an email and submitted his inability to attend the hearing due to personal reasons. The appellant has written that information has not been provided by the respondents. He has sought adjournment of the case.
