ORDER:

 - In connection with point numbers 3, 4, and 8: the record is not available in the official record.
 - In connection with point numbers 5, 6, and 7: requisite information was not supplied being third-party information.
- 4. After discussing with both the parties in detail and examining the case file, I am of the considered view that information in connection with point numbers 5, 6 and 7 is not a third party; accordingly respondent PIO is directed to supply requisite information on respective points (5,6 and 7) to the appellant along with directions to supply an affidavit in original to the appellant in connection with point numbers 3, 4 and 8 with a copy to the Commission within ten days after receipt of this order.
- 5. Both the parties are advised to represent this case on the next date of hearing positively, failing which case will be decided on merit basis.
- 6. The matter is adjourned for further hearing on <u>22.06.2023at 11:00 A.M.through CISCO WEBEX</u> application. Copy of the order be sent to the parties.
