**ORDER:**

1. This order may be read with reference to the previous order dated 22.03.2022 vide which respondent PIO was directed to supply the information again to the appellant via registered post today with a copy of the same to the Commission.  
Appellant was advised to go through the information, once he had received and point out discrepancy within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard. Matter was adjourned for further hearing on 04.05.2023.
2. In today's hearing, appellant states that information in connection with point no. 1 and 2 received only and he is not satisfied with supplied reply in connection with point no. 3, 4, 5, 6, 7 and 8 of the RTI application.
3. Respondent, Sh. Hardip Singh explains as under
  - In connection with point numbers 3, 4, and 8: the record is not available in the official record.
  - In connection with point numbers 5, 6, and 7: requisite information was not supplied being third-party information.
4. After discussing with both the parties in detail and examining the case file, I am of the considered view that information in connection with point numbers 5, 6 and 7 is not a third party; accordingly respondent PIO is directed to supply requisite information on respective points (5, 6 and 7) to the appellant along with directions to supply an affidavit in original to the appellant in connection with point numbers 3, 4 and 8 with a copy to the Commission within ten days after receipt of this order.
5. Both the parties are advised to represent this case on the next date of hearing positively, failing which case will be decided on merit basis.
6. The matter is adjourned for further hearing on **22.06.2023 at 11:00 A.M. through CISCO WEBEX application**. Copy of the order be sent to the parties.
