**ORDER**

1. This order may be read with reference to the previous order dated 30.11.2022.
2. The case has been heard today in the Commission's office at Chandigarh. Shri Mastan Singh, appellant states that no information has been supplied to him.

6. **With the aforesaid directions, the matter is adjourned. Both the concerned parties are directed to attend the hearing on 03.01.2023 at 11.30 am before the Bench at Punjab State Information Commission, Madhya Marg, Sector 16, Chandigarh. Copies of the order be sent to the concerned parties.**
