#### ORDER:

1. The RTI application is dated **23.12.2021** vide which the appellant has sought information **regarding FIR No. 16/19/2/22 PS Bhadson**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **15.2.2022** and Second Appeal was filed in the Commission on **13.9.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **15.11.2022**.

2. Both parties are present. As per the respondent PIO, ASI Hakam Singh from the office of SSP, Patiala, the matter pertains to Police Station Bhadson, which is represented by ASI Sarabjeet Singh. As per ASI Sarabjeet Singh, the entire file pertaining to the matter cited in the RTI application was provided to the appellant in person. ASI Sarabjeet Singh, is however, not able to recall under what number and what date said information was provided to the appellant. The appellant, meanwhile states that he has not received anything from PS Bhadson as claimed by ASI Sarabjeet Singh.

3. The Commission deems it fit to **implead SHO**, **PS Bhadson**, **Inspector Sh. Anwar Ali**, as the deemed PIO in this Appeal Case and hereby directs him to bring all the original record pertaining to this RTI application, to the Commission along with one set of duly attested copies of the same. As per ASI Sarabjeet Singh, some of the information requested in this RTI application is in the custody of PC Branch office of SSP, Patiala.
