ORDER:

(To be read in continuity with earlier orders on 15.11.2022)

1. The RTI application is dated **23.12.2021** vide which the appellant has sought information **regarding FIR No. 16/19/2/22 PS Bhadson**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **15.2.2022** and Second Appeal was filed in the Commission on **13.9.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **15.11.2022**.

2. Both parties are present. The appellant Sh. Hans Raj is accompanied by Sh. Arun Kumar, a final year law student at Punjabi University, Patiala. As per the appellant, it is difficult to make sense of the information provided by the respondent PIO without numbering of the pages supplied and an index showing which page/pages pertains to which point of the RTI application.

3. The respondent PIO, office of SSP, Patiala and SHO-cum-PIO, Bhadson, are hereby directed to supply a suitable reply by way of a pointwise reply to the RTI application including index of the documents provided at each point of the RTI application. All the documents provided must be attested as **"Information provided under the RTI Act, 2005"**. On the request of ASI, Hakam Singh, the respondents are granted 30 days to provide said reply and information. In the event that the reply/information is ready before 30 days. ASI Hakam Singh, is to inform the Commission whereupon the Hearing can be postponed accordingly.
