- 1. The RTI application is dated **23.12.2021** vide which the appellant has sought information regarding FIR No. 16/19/2/22 PS Bhadson, as enumerated in his RTI application. All the documents provided must be attested as "Information provided under the RTI Act, 2005". On the request of ASI, Hakam Singh, the respondents are granted 30 days to provide said reply and information. In the event that the reply/information is ready before 30 days. ASI Hakam Singh, is to inform the Commission whereupon the Hearing can be proponed accordingly.
