ORDER:

(To be read in continuity with earlier orders on 15.11.2022 and 1.12.2022)

- 1. The RTI application is dated **23.12.2021** vide which the appellant has sought information regarding FIR No. 16/19/2/22 PS Bhadson, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **15.2.2022** and Second Appeal was filed in the Commission on **13.9.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **1.12.2022**.
- 2. Both parties are present. The respondent PIO is represented by ASI Hakam Singh from the office of SSP, Patiala and ASI Gurpreet Singh from PS Bhadson. Both respondents have submitted written replies along with the requested information. The appellant however, points out that the information provided by the PIO-cum-SHO, Bhadson is incomplete at point no. 10. Instead of information regarding all the members of the SIT by way of their names and their Rank findings have not been given. Instead only a single member, Inspector Shivender Dev's report has been provided. Regarding point no. 11 wherein the appellant had sought copies of the all summons (parwanas) issued in this matter, ASI Gurpreet Singh, states that said summons (parwanas) are not available.
- 3. In view of the deficiencies pointed out by the appellant, the Commission deems it fit to issue this Show Cause Notice to the PIO-cum-SHO, PS Bhadson Sh. Mohan Singh.
- 4. The respondent <u>PIO-cum-SHO, PS Bhadson Sh. Mohan Singh</u>, is herewith ordered to **SHOW CAUSE** as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on **23.12.2021**.
