ORDER

1. This order may be read to the reference of the previous order dated 04.01.2023.
2. In today's hearing the representative of the PIO, Sh. Devinder Singh, Data Entry Operator states that appellant; Sh. Manjinder Singh is visiting the respondent department on 04.05.2023 for inspection in other RTI cases as per the directions of the Commission. He requests the appellant for the inspection in this case also on the same date i.e. 04.05.2023, so that identified information could be supplied to the appellant as per RTI application.
3. The appellant states that nothing has been delivered with regard to his RTI application till date.
4. In view of above, the request of respondent, Sh. Devinder Singh (DEO) has been accepted. So, Sh. Manjinder Singh is directed to visit the concerned office on 04.05.2023 (Thursday) at 11 a.m. and meet the concerned PIO / officials for collecting the record after inspecting the same as per his RTI.
5. The PIO and other concerned officials including Sh. Gurnam Kumar are directed to be there at the time of inspection on the said date and time on the Appellant's visit. The PIO is also directed to supply the requisite information to the Appellant by hand or send the specific identified record to the Appellant within seven days from the date of inspection in connection with his RTI application, failing which stern action would be initiated against the concerned respondent PIO.
6. If the Appellant, Shri Manjinder Singh will not visit for inspection on the said date and time then it would be presumed that he does not requires the information anymore and the case will be decided on merits.
7. **Matter is adjourned for further hearing on 28.06.2023 at 11:00 A.M. through CISCO WEBEX.** Copy of the order be sent to the parties.
