<u>ORDER</u>

In addition to his submission, the PIO is also hereby given an opportunity under Section 20(1) proviso, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing (through cisco webex) on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte. The PIO is directed to clarify the facts of this case.

- 5. Respondent PIO is directed to comply with the previous order of the Commission dated 04.01.2023 within ten days after receipt of this order, without wasting further time.
- 6. This case is adjourned and both the parties are directed to come up on 22.06.2023 at 11:00 A.M. through CISCO-Webex. Copy of the order be sent to the parties.
