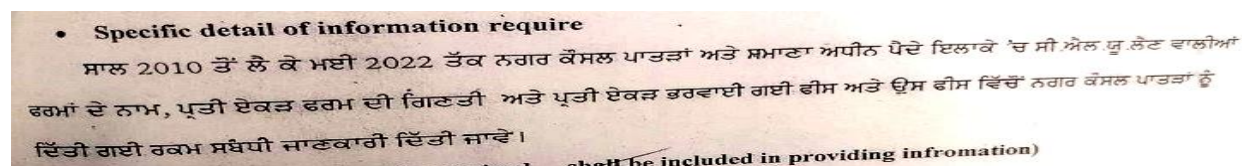

1. The RTI application is dated **26.6.2022** vide which the appellant has sought information:-
