ORDER (FIRST HEARING):

- 1. The RTI application is dated 30.06.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 05.08.2022 and Second Appeal was filed in the Commission on 20.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 21.02.2023.
- 2. The Respondent states that information sought by the appellant is under consideration before the Tehsildar, Amloh and reply in this regard has already been sent to the appellant whereas the Appellant denied the same.
- 3. Since, the information sought by the appellant is to be supplied by the PIO O/o Tehsildar, Amloh, therefore, the PIO O/o Tehsildar Amloh is impleaded as Respondent No. 2 in this case.
- 4. The PIO O/o Tehsildar, Amloh is directed to supply information as sought by the appellant, under intimation to the Commission, before the next date of hearing. In case the information as sought by the appellant is not available in the official records, then PIO is directed to file an <u>Undertaking</u> in this regard and produce the same before the Bench, on the next date of hearing, failing which <u>PENALTY</u> will be imposed upon him as per provisions of the RTI Act, 2005.
